

FIRST AID MEASURES

EYE CONTACT : IMMEDIATELY FLUSH EYES WITH LOTS OF RUNNING WATER. SEEK MEDICAL ATTENTION IF IRRITATION PERSISTS.

INHALATION : REMOVE TO FRESH AREA.

INGESTION : DRINK LARGE QUANTITIES OF WATER AND SEEK MEDICAL ATTENTION IMMEDIATELY.

SKIN CONTACT : WASH SKIN WITH WATER. IF IRRITATION OCCURS SEEK MEDICAL ATTENTION AS NEEDED.

SECTION VI REACTIVITY DATA

STABILITY: STABLE

INCOMPATIBILITY(MATERIALS TO AVOID): STRONG ACIDS, OXIDIZERS.

HAZARDOUS POLYMERIZATION: WILL NOT OCCUR

CONDITIONS TO AVOID: NONE CURRENTLY KNOWN.

HAZARDOUS DECOMPOSITION: NONE KNOWN.

SECTION VII SPILL OR LEAK PROCEDURES

CLEAN-UP PROCEDURES: CONTAIN SPILL WITH INERT MATERIAL SUCH AS SAWDUST, THEN TRANSFER TO SEALABLE CONTAINERS FOR DISPOSAL. FLUSH CONTAMINATED AREAS WITH WATER.

RECOMMENDED WASTE DISPOSAL METHOD: DISPOSE OF IN ACCORDANCE WITH ALL APPLICABLE FEDERAL, STATE AND LOCAL REGULATIONS.

SECTION VIII SPECIAL PROTECTION DATA

RESPIRATORY PROTECTION : GENERALLY NOT REQUIRED.

EYE PROTECTION : SAFETY GOGGLES.

PROTECTIVE CLOTHING : FULL-LENGTH CLOTHING.

VENTILATION : GENERAL ROOM VENTILATION

OTHER PROTECTIVE MEASURES: EYEWASH AND SAFETY SHOWER.

DISPOSAL OF EMPTY CONTAINER: EMPTY CONTAINERS SHOULD BE TRIPLE RINSED WITH WATER AND DISPOSED OF PURSUANT TO LOCAL, STATE, AND FEDERAL REQUIREMENTS.
