### 2. Hazards Identification

*Emergency overview:* Danger – Corrosive. Corrosive to the eyes, skin, gastrointestinal tract, and respiratory system.

**PRECAUTIONARY STATEMENTS:** Causes irreversible eye damage and skin burns. Do not get in eyes, on skin, or on clothing. Wear goggles or face shield, rubber gloves and protective clothing. Harmful if swallowed. Remove contaminated clothing and wash before reuse. Wash hands before eating, drinking, chewing gum, using tobacco or using the toilet.

#### **SIGNS AND SYMPTOMS OF EXPOSURE (SKIN, EYE CONTACT; INHALATION; INGESTION)**

**EYE CONTACT :** Causes burns and may result in permanent injury to eyes including blindness.

**INHALATION :** Mists and vapors can irritate the throat and respiratory tract. High vapor concentrations may cause central nervous system effects. Symptoms may include headaches, dizziness, and drowsiness. Harmful if inhaled.

**INGESTION :** Although relatively low in toxicity, ingestion can cause gastrointestinal irritation, swelling of the larynx, difficulty in breathing, circulatory shock, convulsions and possibly death.

**SKIN CONTACT :** Causes corrosive burns. Brief exposures may cause irritation and defatting of the skin. Exposures not promptly washed off may lead to toxic effects similar to ingestion. Harmful if absorbed through the skin.

#### 4. First Aid Measures

*EYES:* Immediately flush eyes with a directed stream of water for at least 15 minutes. Hold eyelids apart to ensure complete irrigation of all eye and lid tissues. Washing eyes within several seconds is essential to achieve maximum effectiveness. Get medical attention immediately.

*INGESTION:* Call a poison control center or doctor immediately for treatment advice. Have a person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control center or doctor. Do not give anything by mouth to an unconscious person. Note to physician: Probable mucosal damage may contraindicate the use of gastric lavage.

*SKIN CONTACT:* Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control center or doctor for treatment advice.

*INHALATION:* If symptoms are experienced, move victim to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably mouth-to-mouth if possible. Call a poison control center or doctor for further treatment advice.

#### 5. Fire Fighting Measures

*FIRE FIGHTING METHOD:* Move container from fire area if it can be done without risk. Cool containers with water. Avoid contact with skin and wear NIOSH approved breathing apparatus.

*EXTINGUISHING MEDIA:* Use extinguishing agents appropriate for surrounding fire.

*UNUSUAL FIRE OR EXPLOSIVE HAZARD:* Irritating and toxic gases or fumes may be released during a fire.

#### 6. Accidental Release Measures

*PERSONAL PRECAUTIONS:* Isolate area. Keep unnecessary personnel away.

*ENVIRONMENTAL PRECAUTIONS:* Keep out of sewers, storm drains, and waterways.

*CLEAN-UP PROCEDURES:* Only trained and properly protected personnel should be involved in spill clean-up operations. Wear alkaline-resistant suit and complete protective equipment; rubber gloves, rubber boots, and chemical goggles. Use a non-combustible material like vermiculite, sand, or earth to soak up the product and place material in sealable waste containers for disposal.
